

Regulations for the Prestoungrange Doctoral Scholarships at Revans University

Background

Gordon Prestoungrange, The Baron of Prestoungrange, is Chancellor of Revans University and one of the founders of IMCA. Professor Prestoungrange was instrumental in the appointment of Professor Reg Revans, the acknowledged father of action learning, as IMCA's founding principal in the early 1980s. Since 1988 he has been committed to assist the people of Vanuatu through the provision of action learning programmes. As he said at IMCA's Oxford graduation ceremony in 2009,

"Vanuatu has played a most significant part in the global growth and development of action learning and our own institutions. It was your founding Prime Minister Dr Father Walter Lini who asked us to establish Revans University in Vila as we took kava together and as he presented us with our tam tam."

These scholarships recognise Dr Prestoungrange's commitment to lifelong action learning and honour his resolve to support Vanuatu and its people on their journey as a truly independent South Pacific island nation.

Regulations

- 1. The Scholarships will be known as the Prestoungrange Scholarships.
- 2. The Scholarships are open for applications to all individuals permanently residing in Vanuatu, wishing to pursue Revans University Action Learning business focused doctoral studies.
- 3. Applicants need to have completed a Masters level degree.
- 4. Applicants who have undertaken study outside Revans University must supply a verified copy of their academic transcripts.
- 5. Revans University Action Learning programmes are typically completed whilst in managerial employment, with the learner's workplace doubling as his or her 'laboratory'. The Prestoungrange Scholarships work on the same principle.
- 6. Accordingly, the scholarships have a value of US\$21,000 each, this sum being the published enrolment fee globally. Subsistence allowances are not included.
- 7. The Scholarships are specifically focused on delivery of the Doctor of Business Administration programme.
- 8. Applications are to be made by 31 March 2010.
- 9. Shortlisted applicants will be interviewed in Port Vila by a panel chaired by the Chairman of the Revans University Advisory Board, Dr Thomas Beyer (hc).
- 10. The selection of the scholars is merit based, with previous learning outcomes, references and the indicative research topic all contributing to the selection decision.
- 11. Applications must be supported by two personal written references and a one page personal statement introducing the applicant and discussing what the applicant intends to accomplish with the aid of the Scholarship.
- 12. The intention is to offer up to five scholarships, subject to sufficient suitably qualified applicants being available.
- 13. Successful applicants will be notified by 15th May 2010.
- 14. The programme will commence in June 2010.
- 15. Applicants will need to complete the application form and submit it, together with other required documents to the IMCA Global Registrar at *imc@imcassociation.edu* or IMCA Global Registry, PO Box 101 245, NSMC, Auckland, New Zealand 0745.
